However, I recognize that K9 Pawsitive Training is not responsible for any unintentional errors, omissions, or incorrect assertions. I understand that the recommendation of any product or service is not a guarantee of my satisfaction with that product or service. Further, I am and will remain responsible for the actions of my dog at all times and I hereby agree to indemnify and hold harmless K9 Pawsitive Training of any and all claims of injury, expense, costs, or damages caused by the actions of my dog while under K9 Pawsitive Training instruction or control and under my own care as a result of following training instructions. I have been told by K9 Pawsitive Training and understand the inherent risks of owning a dog, including but not limited to the risk of dog bites to myself or others.
2. I authorize Emergency medical care to be provided for my dog by an appropriate veterinarian to be determined by K9 Pawsitive Training. I understand I am responsible for any and all veterinary costs and agree to reimburse K9 Pawsitive Training for any charges related to emergency care. I understand that K9 Pawsitive Training is willing to take responsibility for vetting if an incident or injury happens to my dog during the course of the training.
3. I understand that all dogs will be boarded at owner's home address of 3109 Sunset Ave., Bakersfield, CA 93304. Owner gives the K9 Pawsitive Training permission to transport dog(s) to and from the Bakersfield location for boarding purposes. They further understand the inherent risks associated with transportation such as, but not limited to, loss or injury due to accident; owner agrees to assume all risks and financial costs associated with said transportation.
4. I understand that my dogs will be trained using balance reinforcement methods. I also understand that training equipment such as E-collars might be use if needed during the course of training but only with owner's consent. I also understand that although my dogs will learn multiple behaviors, basic obedience, new routines, and management while in the care of the K9 Pawsitive Training, it is my responsibility to maintain this learning upon their return to the home environment. Dogs do not generalize well. This means that behavior taught while in our care will only be solidified through clear, calm and consistent repetition once home. K9 Pawsitive Training recommends owners to continue education through group classes and private instruction to proof and generalize training.
5. Animal behavior is never fixed or static; it changes depending on circumstance and environment. Even trained behaviors will fade or extinguish over time without consistent repetition and practice. Especially in cases of fear or aggression, although behavior may be modified, the dog is never "cured". A dog's behavior is ultimately the responsibility of the owner.
6. K9 Pawsitive Training cannot guarantee that they can fully potty train my dog. They can introduce my dog to a routine that will teach the idea of pottying is outside only so its important that I'm able to continue the routine to avoid indoor incident until my dog is fully house broken.
7. I understand that I will not be sue if my dog ever has a bite incident with his/her trainer/handler or caused any injury such as a fall to his or her trainer/handler.
